#### **COURSE OFFERINGS:**

#### **OXFD3302 BIBLICAL JUSTICE AND MINISTRY**

The course reviews biblical principles dealing with personal and social justice, including their implications for practical ministry situations. Christians are called to communicate biblical justice in a way that shows the power of the Christian Gospel to change people's lives. The course will provide an understanding in how best to communicate biblical justice in love and truth in a revolutionary way

#### **OXFD6302 BIBLICAL JUSTICE: PASTORAL CONSIDERATIONS**

The course is an analysis of biblical accounts related to personal and social justice, with special focus on implications for pastoral ministry. Pastoral ministers are called to communicate biblical justice in a way that impowers the Gospel to change people's lives. This course will provide an understanding of how best to implement biblical justice in love and truth in a revolutionary way.

## **COURSE OFFERINGS:**

#### **OXFD3301 JESUS REVOLUTION**

The course examines the Jesus People movement among hippies and youth and was one of the most significant spiritual awakenings in the United States in last half of the 20th century. This course gives special attention to the history and significance of that movement on Christianity in the Western world.

#### **OXFD6301 JESUS REVOLUTION: POST WORLD WAR II RENEWAL MOVEMENTS**

The course examines the Jesus People movement among hippies and youth and was one of most significant spiritual awakenings in the United States in the last half of the 20th century. This course gives special attention to the history and significance of that movement on Christianity in the Western world. The course also surveys other post WWII renewal movements and awakenings that helped spawn renewed emphasis on the presence, power, and gifts of the Holy Spirit.

**A \$300 non-refundable deposit is required at time of application.** Deposit must be received for application to be considered. Applications considered on first come first deposit paid basis.

All applications <u>need to be</u> due by **February 29<sup>th</sup>, 2024**. Applications will be accepted until the course is full or only after May per discretion of the Oxford Experience department. Applicants who have paid a deposit are accepted in the following order:

- Credit students opting to go to both weeks of Oxford.
- Credit students opting to go to *only* one week of Oxford.
- Audit students.

Credit students are always given priority. There is no provision for a student to withdraw from an audited course, and no refunds are issued for audit fees or trip fees previously paid.

The Oxford Experience Trip must be paid in full by May 13<sup>th</sup> 2024. To ensure that each student is prepared to go, it is important to make monthly payments on the GoMethod website by the following dates (see page 5 & 6). If you are utilizing FAFSA benefits you must contact Student Financial Services before January 8<sup>th</sup>, 2024 to arrange FAFSA to be used for the Oxford Experience.

You MUST have a passport whose expiration date is after December 2024!! If you do not have a passport, or it will expire before December 2024, you must apply for one <u>before</u> March 2024. Many countries require valid passports 6 months after your scheduled trip. This year the UK is <u>no longer</u> requiring **Electronic Travel Authorization (ETA)** you should apply at GOV.UK the price is £10 if this becomes a requirement again. This may change and more information to come on this.

Students who have a registration hold due to excessive incomplete courses (IN) or not meeting Satisfactory Academic Progress (SAP) will automatically be withdrawn from the Oxford course. **Trip fees and deposits will be non-refundable**. Students will be considered on a <u>case-by-case</u> basis whether they will be able to attend the summer course once their incomplete is concluded, with a possibility of being denied. Students who have graduated must apply as an audit student to attend the summer after their final semester.

- If you are an Audit student, you cannot utilize FAFSA or VA loans.

- First payment of the amounts listed on pages 5 & 6 above are due on January 8<sup>th</sup>. The monthly amounts will then be due every second Monday of the month until May 13<sup>th</sup>.
- Payments are due every second Monday of the month. If payments are more than 5 days late, the student forfeits their place at Oxford and all monies paid toward the trip fee are non-refundable.
- **Deposit and Trip Fees are non-refundable**. Tuition refunds/credits are given for withdrawal from a course(s) when an official Add/Drop Form is completed with the Registrar. Students may withdraw from a course and receive a tuition refund per the dates on the schedule below.
