



Articulation Agreement

National Institute of Christian Leadership and The King's University

Recognizing the historic and unified vision of National Institute of Christian Leadership and The King's University to train the next generation for life-transforming ministry, this Articulation Agreement presents a formal collaboration between the two institutions for the purpose of fulfilling the mission of both organizations. National Institute of Christian Leadership (NICL) and The King's University (TKU) agree to the following:

Acceptance of NICL Graduates: The King's University, accredited by the Association of Biblical Higher Education and the Transnational Association of Christian Colleges and Schools, agrees to accept into its degree programs qualified NICL graduates who have been accepted to attend TKU.

Transfer Credit: NICL attendees are eligible for advanced placement under the following guidelines:

1. Application must be submitted, and acceptance to TKU received.
2. The NICL Certificate of Completion must be presented at time of application submission.
3. Each NICL session potentially qualifies for three graduate semester hours up to a maximum of 12 graduate semester hours for all four sessions into the Master of Practical Theology or the Master of Divinity.
4. NICL sessions will satisfy the course lecture content; additional course post-work is required for each course.
5. Upon completion of course post-work, credit will be placed on student transcript as a Pass/Fail.
6. Student must have completed an accredited bachelor degree or qualify for admission under the special student provision, subject to admissions guidelines.


Scholarships and Financial Aid: TKU participates in the Federal Student Aid Program. Additionally, NICL graduates who enroll in classes on the Gateway Campus will qualify to apply for The Blessed Life Scholarship, which awards annual scholarships based on the number of hours registered.

Administration and Support Service: NICL and TKU agree to extend consideration and support in administrative areas to ensure the smooth transition for NICL students who transfer to TKU.


Communications: Both NICL and TKU affirm the right to promote this articulation agreement and its terms in appropriate communications. This includes advertisements, promotional events, web site, alumni, and communications such as bulletins, newsletters, and catalogs. NICL further agrees to allow TKU representatives access to NICL sessions for marketing and recruitment purposes.

This agreement represents a revision to the articulation agreement dated December 12, 2013 and will remain in effect in perpetuity unless written notice is provided by either party regarding revision or discontinuation. It is our prayer that this agreement will foster a partnership that will enhance the fulfillment of the mission and objectives of each institution and advance the work of the Kingdom of God.


