Tuition refunds/credits are given for withdrawal from a course(s) prior to the start of a term or when an official Add/Drop Form is completed with the Registrar. Students may withdraw from a course and receive a refund per the dates on the schedule below. The date of withdrawal is certified as the date on which the Add/Drop Form is filed with the Registrar (not the date of last attendance in class). Fees for all courses, including withdrawn/dropped course(s), are the responsibility of the student effective the first day of the 50% refund period. Charges for added courses will appear on student's ledger and should be paid when added.

Failure to attend class does not constitute withdrawal. Students failing to properly withdraw from a course will not receive a refund.
