APPLICATION, PAYMENT, AND ENROLLMENT POLICIES

A \$300 non-refundable deposit is required at time of application. Deposit must be received for application to be considered. Applications are considered on first come first deposit paid basis. Applications will be accepted until the course is full or until May per discretion of the Oxford Experience department.

Applicants who have paid a deposit are accepted in the following order:

- Credit students enrolling in both weeks of Oxford.
- Credit students enrolling in one week of Oxford.
- Audit students.

Credit students are *always* given priority. There is no provision for a student to withdraw from an audited course, and *no refunds* are issued for audit fees, trip fees or deposit fees previously paid.

The Oxford Experience Trip must be paid in full by **May 21st, 2026**. To ensure that each student is prepared to go. If you are utilizing FAFSA benefits you must contact Student Financial Services before **January 8th, 2026**, to arrange FAFSA to be used for the Oxford Experience.

You **MUST** have a passport whose expiration date is **after December 2026!!** If you do not have a passport, or it will expire before December 2026, you must apply for one before March 2026. Many countries require valid passports 6 months after your scheduled trip.

The UK has implemented a **£16 (\$13) Electronic Travel Authorization** for travelers to the UK. You must purchase this on your own. It allows you to enter the UK multiple entries within a 2-year period. <https://www.gov.uk/guidance/apply-for-an-electronic-travel-authorisation-eta>

Students who have a registration hold due to excessive incomplete courses (IN) or not meeting Satisfactory Academic Progress (SAP) will automatically be withdrawn from the Oxford course.

Trip fees and deposits will be non-refundable. Students will be considered on a case-by-case basis whether they will be able to attend the summer course(s) once their incomplete is concluded, with a possibility of being denied. Students who have graduated must apply as an audit student to attend the summer after their final semester.

Full payment is required by **May 21st 2026**.

If you wish to pay using a payment plan, please sign up in the student portal.

- To use a 3-payment plan, sign up by April 3rd.
- To use a 2-payment plan, sign up by May 3rd.

Once your application is received, you can begin making payments in the **GoMethod** portal, allowing you to spread out costs and avoid paying all at once. You will also receive a personalized fundraising link to share with friends and family who want to support your Oxford journey.

If you do not sign a payment plan with Student Financial Services then the full amount is due **May 21st, 2026**.

*FAFSA & VA Benefits to cover tuition and fees require application by **December 16th, 2025**. FAFSA & VA Benefits do not cover the costs of the trip fee, airfare or travel expenses, only tuition and administrative fees. If you are an Audit student, you cannot utilize FAFSA aid or VA benefits. If utilizing FAFSA aid or VA benefits the course must be on your degree audit or you must request and get an approved course substitution. Those using VA benefits and an approved course substitution: Student Financial Services needs a copy of the approved substitution for your file.

Deposit and Trip Fees are non-refundable. Tuition refunds/credits are given for withdrawal from a course(s) when an official Add/Drop Form is completed with the Registrar. Students may withdraw from a course and receive a tuition refund per the dates on the schedule below.
